

## **PUBLIC DECLARATION**

KOOPERATIVA poist'ovňa, a.s. Vienna Insurance Group, with registered office at Štefanovičova 4, 816 23 Bratislava, ID No.: 00 585 441, registered in the Commercial Register of the Municipal Court of Bratislava III, Section: Sa, Insert No.: 79/B (hereinafter referred to as "KOOPERATIVA")

## With this PUBLIC DECLARATION

extends the insurance cover of the insurance contract of the product "Long-term travel insurance for personal accounts of clients of Slovenská sporiteľňa" (hereinafter referred to as "Travel Insurance") mediated for KOOPERATIVA by Slovenská sporiteľňa, a.s., with registered office at Tomášikova 48, 832 37 Bratislava, ID No.: 00 151 653, registered in the Commercial Register of the Municipal Court of Bratislava III, Section: Sa, Insert No.: 601/B,

to cover medical costs directly related to the COVID-19 disease caused by the SARS-CoV-2 virus (hereinafter referred to as 'COVID-19 disease'), under the terms of this public declaration.

KOOPERATIVA hereby addresses, pursuant to Section 850 of Act No. 40/1964 Coll. of the Civil Code, as amended, to each person who is entitled to receive insurance benefits under the Travel Insurance Policy (hereinafter referred to as the "Insured"), the following **public declaration** for the provision of insurance benefits in the event of coverage of medical expenses related to COVID-19, under the following conditions:

a)	Medical expenses in connection with COVID-19 Disease to the extent specified in the General Insurance Conditions for Long-Term Travel Insurance for Personal Accounts of Clients of Slovenská sporiteľňa in Part II, Article 15, which are related to outpatient treatment and hospitalization of the Insured.	up to the amount of medical expenses
b)	Quarantine. The cost of the Insured's accommodation abroad in the event that the Insured has been ordered to be quarantined in accordance with the legislation in force in the country where the Insured is located. The insurance does not cover the cost of accommodation in the event of quarantine being ordered, when travelling abroad, if the Insured travels to a country where compulsory quarantine is ordered on entry.	50 EUR/night, max. 14 nights
	<b>Travel costs</b> for transporting the Insured back to his/her home country in the event that due to quarantine the Insured had to stay abroad longer than he/she was supposed to do according to the booking of the stay/tour or trip in connection with which this insurance was taken out (e.g. after the planned end of the trip). The above applies provided that the Insured was unable to use the originally agreed means of transport due to quarantine.	750 EUR / insured
	KOODERATIVA reserves the right to decide in advance on a suitable accommodation facility or mode	of transport and the

KOOPERATIVA reserves the right to decide in advance on a suitable accommodation facility or mode of transport and the Insured undertakes to respect this decision, otherwise KOOPERATIVA will only provide cover for the accommodation or travel costs incurred to the extent that it would have provided cover under the claims procedure in accordance with this sentence. The Insured shall notify KOOPERATIVA without undue delay of the occurrence of the insured event and await its instructions pursuant to the preceding sentence.

## The conditions for entitlement to payment of the insurance benefit according to the Public Declaration:

- The Eligible Person has an insurance policy with an effective date of 17.06.2023 at the earliest and the occurrence of the insured event has occurred on 17.06.2023 at the earliest.
- 2. At the time of the insured event, the premium due on the Travel Insurance is fully paid.

<sup>\*</sup>The limit of indemnity applies to one and all insured events in one insurance period.

- 3. The insured event occurs during the validity and effectiveness of the Travel Insurance.
- 4. The medical expenses were incurred in connection with COVID-19.

The validity and effectiveness of this public declaration shall commence on the date of its signature and shall continue until revoked or amended by KOOPERATIVA.

The Insured shall have no legal claim against KOOPERATIVA for benefits in excess of the maximum promised amount of insurance benefits under this public declaration.

KOOPERATIVA reserves the right to revoke or amend this public declaration at any time, while claims arising under the terms and conditions set out there in shall remain unaffected for the duration of its validity.
